Letter from Minister Heather Leffler

Friends in Christ,

Had we been told at the beginning of 2020 that many of us would not see each other face to face for 10 months, I can't imagine how we would have planned for this unusual year in the life of our churches. What I do know is that even before the pandemic closed our buildings, the Spirit was guiding us at Rockwood and Stone to care for each other, to stay connected and to continue to serve God faithfully.

The Spirit turned casual conversations with William Stiles and Melanie Running and the input of our Worship and Christian Education Committees into Contemplation and Conversation. The first reflection sent on the second Sunday in January was intended to offer busy families and students who were away at school a spiritual practice when they couldn't attend church. Thanks to people like the Bakers, who print and deliver copies of these reflections to folks who are not able to worship with us online, a sense of togetherness has been maintained during the pandemic.

Our regular activities carried on in January, February and early March. In addition, Rockwood hosted a delightful Robbie Burns dinner on a very stormy January evening. The Spirit inspired the Outreach Committee to deliver delicious meals to people who couldn't attend and sowed the seeds for Food Fixes, Breakfast for Dinner and Take-Out Dinners that would become so important later in the year.

In March, when larger churches closed because of COVID-19, the Spirit nudged us to meet for one last Sunday. It was an unusual morning with people standing distanced from one another wondering what was ahead. Taking time to talk after worship about how we could care for each other and stay connected through the coming weeks, which turned into months, the Spirit birthed Circles of Care. I spent the next two weeks with the help of phoners from Stone connecting with most of you by phone or email. It was a gift to talk with you. It continues to be a gift when you reach out with stories of how your calls turned into video chats or singing together; when you call to share concerns about someone in our congregations or when you contact me with suggestions for our ministries.

Your responses to the invitation of the Spirit have been amazing. You took the risk and learned Zoom ... shared your gifts of music online for our worship services and in person to support families saying goodbye to loved ones at graveside funerals ... planned and participated in fun fundraisers ... helped build a teaching lodge and wampum path at Anishnabeg Outreach ... took part in the spring clean up and renovations in the Jeanne Jackson room at Stone, and made improvements inside and outside at Rockwood ... and joined in outdoor worship at Ray and Ellen Thomson's and in the Stone cemetery – all masked and socially distanced events designed to care for each other. Regular activities moved online or were reimagined.

When people expressed a longing to see our sanctuaries, the Spirit guided our conversation and our amazing volunteers to create Advent candleholders for our church families to help us feel connected.

While other churches spent a lot of time and energy opening their buildings in the fall, those of you not on Zoom assured us that you were comfortable with staying safe at home. This meant we could focus our energy on decorating the outside of our churches; gathering items for the foodbank in a unique way; and sending a flyer to our communities to share what we have been doing and wish them well.

This has not been the year we imagined, and we would never have wished for it, but I am deeply gratefully that we have journeyed through it together. I trust that we have been held by the Spirit and will come through the pandemic with many learnings that will help us grow in deeper relationship with God and each other.

Pastoral Charge Board

The Pastoral Charge Board met three times in 2020. The following highlight actions taken by the Board:

- Approved the Rockwood-Stone website and domain be moved from Weebly to Chris Barlow hosting them
- Accepted the following statement of principles to guide the work of the Rockwood-Stone Pastoral Charge

Principles that Guide the Work of Rockwood-Stone Pastoral Charge

The Pastoral Charge Board believes that the work of the charge at all levels should be deeply intentional with a focus on ministry in its many forms. Emphasis should be placed on developing, empowering, and releasing people to engage in meaningful ministry in keeping with their individual gifts.

Approach to Governance

Committed to growing and living as disciples and followers of Jesus, we believe in an approach to governance that mirrors the teachings associated with the gospels. Discussions, decision-making, and actions taken at any level of governance should be made in a safe, nurturing atmosphere characterized by the following:

- Healthy relationships
- Honest, constructive dialogue leading to consensus
- Regular prayer and discernment
- Growth in understanding of The United Church's mission, guiding principles, focus, and culture ...
- Enhancement and celebration of inclusivity and diversity
- · Permission granting rather than permission withholding culture
- · Emphasis on the future rather than day to day management
- Growth in the understanding of mandated tasks (especially Board/Councils and those which may be easily delegated)
- Dedication to being good stewards of God's world
- · A willingness to evaluate ministries of the congregations on a regular basis

This is a living document.

- Approved that Worship and Christian Education, and Pastoral Care and Fellowship be committees in both our congregations
- · Approved a New Discernment Circle and New Initiatives Policy
- Adopted the following policies as living documents: Terms of Reference for the Pastoral Charge Board, the Finance and Stewardship Committee, the Ministry and Personnel Committee, the Worship Committee, and the Trustees
- · Amended Position Descriptions for Board Chair, Board Secretary, and Pastoral Charge Treasurer
- Approved the following meeting schedule for the Board, our Councils and Combined Committees effective September 2020:

- two meetings of Board in May and November
- two meetings of Councils in January and September
- two meetings of Finance and Stewardship in April and October
- three meetings of Pastoral Charge Worship in January, April and September
- · Annual Meetings the first and second or third Sundays in February depending on Family Day
- all Committees to meet as needed to fulfill their mandates

Approved the establishment of a Church Reopening Commission with the following members: Brian Mack, Bill Allen, Jack Ward, Liz Guthrie, Steve Thomson, Sherol Steinberg, Rosslyn Bentley, Barbara Eley, Kay Mathies, Marcia Haworth, and Rev. Heather Leffler. According to United Church policy, the commission has the power of the Board and reports to the Board for information only. The Commission was tasked with the responsibility to research what needs to be done before our churches can safely reopen, to put together a plan for reopening, to communicate the plan to the congregations, and to put the plan in place.

- · Created a Zoom Worship Discernment Circle members added following the Board meeting were Rev. Leffler, Lisa Leffler, Ed Nagel, and Chris Arbuckle
- · Endorsed the purchase of a new designated laptop for the use of the church secretary
- Discussed and endorsed the proposed Pastoral Charge budget as a living document
- Adopted the Terms of Reference for Pastoral Charge Board Nominations
- Approved spending of up to \$150 to create Advent wreaths for each active household in the Pastoral Charge

As the above outline indicates it was a very fruitful year for the Pastoral Charge Board especially in the area of reviewing policy and updating procedures. As a governing body, we are especially indebted to Brian Mack, Bill Allen, Heather Leffler, Heather DeJonge, Sherol Steinberg, and Sarah Leffler who formed the Governance Discernment Circle. This group was given the task of examining the model of governance which had been in existence since 1989, streamlining it to better conform to the current requirements of the Manual and to provide detailed terms of reference in line with existing and future needs of our charge.

Looking forward to 2021, the Board will continue to receive reports as to the further work of the various on-going committees, the Reopening Commission, the Governance Discernment Circle, the Affirming Discernment Circle and the Zoom Worship Discernment Circle. A workshop regarding governance led by Bill Allen is anticipated.

The Affirming Discernment Circle met in person at the start of the year. We took a break when the pandemic hit because at that point not all our members had internet at home, and we decided it was important to meet as a whole group. We were able to resume regular meetings in September and November via Zoom.

Throughout the year members of the Affirming Discernment Circle participated in webinars and events to help expand our understanding of what it means to be affirming. This includes but is not limited to the *Becoming a Trans Ally* webinar by United in Learning (webinars/recordings/336-becoming-a-trans-ally), a concert by the Waterloo-Wellington Rainbow Chorus — a community choir that welcomes members of all genders, sexualities and gender expressions and allies of the LGBTQ+ community, and an Autism and the Church workshop led by Grant Macaskill.

In order to share some of these learnings with the congregation, the Affirming Discernment Circle has added a section in Contemplation and Conversation. This section has included reflections and links to information provided by the Affirming Discernment Circle as well as videos and articles shared with us by congregation members. We also offered the opportunity to discuss these reflections, videos and/or articles after worship. We had one discussion group in the fall and hope to have more in the new year.

We will be leading worship the second Sunday in January. For the message portion of the worship service, Marion Bascom graciously agreed to share her story of her daughter coming out. If you have a coming out story or a story about how racism, sexism, ageism, ablism (or any other "ism") has impacted your life that you are willing to share with the congregation, please contact a member of the circle so we can discuss options of how that can be done.

We look forward to hosting workshops and conversations in the new year as we explore ways to ensure that Rockwood Stone is and continues to be a safe place for everyone to worship together.

Crafts included making candle holders out of tin cans, matchstick crosses, water painting meditation boards and star Christmas trees.

Finance and Stewardship

At the outset of the pandemic in March, a letter was received from the national church concerning finances in a time of crisis. In response to this letter, a message was drafted, edited by email, and sent to our congregations outlining how people could continue to donate through postdated cheques, PAR, e-transfers and Canada Helps. Thanks to Chris Barlow for setting up dedicated emails for our treasurers to receive e-transfers – rockwooduc.treasurer@gmail.com and stoneuc.treasurer@gmail.com.

The committee met in April by Zoom. Bill had correspondence from a law firm specializing in church and charity organizations. After reviewing the information provided concerning the risks associated with church operations in a pandemic, the committee discussed how we would respond if the lockdown lasted for an extended period of time. Ensuring the well being of our church members was of upmost importance. Heather had purchased a Zoom license for her personal use and offered to use it for the Pastoral Charge for this year. We recommended and the Board, in turn, accepted Chris Barlow's gracious offer to create a new website and host it.

In subsequent months, a number of committee members continued to view the weekly webinars Erik Mathiesen, Chief Financial Officer of the United Church, offered for treasurers. These were very helpful in the beginning, especially relating to the 10% Temporary Wage Subsidy for Employers. Roy worked with ADP to access this benefit and explored the Canada Emergency Wage Subsidy. Thanks to the continued support of our members, we never qualified for the second subsidy.

The Operation Haircut fundraiser was planned to provide support for our churches. Heather's offer to have the congregations vote on whether she should shave her head with 80% of givings going to local, 10% to M&S and 10% to Outreach in the congregations was accepted. Sherol Steinberg and Lisa Leffler organized the fundraiser and publicity. People received one vote for every \$10 they donated. Following worship on May 3, Heather's head was shaved. \$1970 was divided as she had requested.

Throughout the summer and fall, our treasurers and minister met regularly to ensure that both congregations were able to meet their expenses. We added a podcasting license to our One License account. In the fall, a letter offering ways to support our churches was sent to members who had not been supporting our churches financially since the beginning of the pandemic.

At our meeting via Zoom in October, it was decided that we would send a Christmas flyer to the community celebrating and offering thanks to the wider community for our various successful projects throughout 2020 – Operation Haircut, Anishnabeg Outreach, Garden Tour, Take Out Dinners, CFGB Project, and the Food Fix. The flyer also highlighted on-going activities and extended an invitation to the Carol Sing and Christmas Eve services. As our secretary has been using her own computer when working from home and the church computer is close to 10 years old, we recommended to the Board that a laptop be purchased for the office. This recommendation was accepted, and software was purchased through Tech Soup. \$4,000 was transferred from the Manse Fund to the General Fund. The committee offered input for the proposed 2021 Pastoral Charge budget.

In November, Bill Allen, Heather Leffler, Brian Mack and Sherol Steinberg took part in a four week Called to be the Church – Stewardship Best Practices module. Dave Jagger, Western Ontario Waterways Stewardship and Gift Officer, led the webinars.

The committee is very grateful to our treasurers Roy Steinberg, Bill Allen and Amanda Hunter-Anthony for their ongoing commitment and the extra work they did this year because of the pandemic.

Ministry and Personnel

Rosslyn Bentley and Brian Mack met with Heather in September 2020 to complete her annual review. Heather was thanked for the flexibility and creativeness of her response and leadership both initially and ongoing during the COVID emergency. We feel so blessed for Heather's ongoing leadership and wisdom.

The M&P Committee met on November 8, 2020 and recommended to the Pastoral Charge Board that the minister and secretary receive the 2.2% cost of living increase mandated by the United Church.

Our church secretary, Sharyn Southworth, continues to work from home throughout the COVID response. A new laptop was recommended by the Finance and Stewardship Committee to facilitate her work. In compliance with church policy, Sharyn provided a current Annual Declaration in December

2020. (After an initial police record check, the United Church now has staff make an Annual Declaration of Criminal Charges.)

In 2018 Heather was called as a commissioner to General Council 43 in Oshawa. The GC43 met twice during COVID. Heather mentioned the important upcoming work of becoming a racialized church.

The Circles of Care have been reaching out to try to ensure those who are unable or do not want to participate via Zoom remain connected.

Along with the other church staff, our two church organists Liz Guthrie and Heather Blair have ably adapted to the COVID emergency with weekly music along with the Eramosa Ensemble and many individuals and families who have provided wonderful special music to support our virtual worship.

As people of faith, we are so accustomed to the companionship of regular worship and prayer, meeting virtually is a pale imitation of the close companionship that enforces our close bonds. Yet it is this testing time that reveals our ability to sustain and create true fellowship. Our two churches have never been closer. As a church we are drawing closer together, we are paying attention to how we connect and how we hold each other and our community with love. So many people are struggling and yet we are succeeding to change, even just connecting by Zoom or phone is something new and fruitful.

Thank you to the members of the M&P committee for your faithful service. Everyone on the committee provides service to the churches in many different ways and has been on the committee for many years and we are so grateful.

Thank you all for your service and faithfulness: being a people whose outreach is so key in the health and spiritual growth of our community, especially at this time. Let us celebrate how we have continued to offer a pathway to God together. Let us continue to open our churches to all who want and need to be in relation with a faith community.

Minister's Report to Ministry and Personnel for 2020

Worship – Working with our combined Worship and Christian Education Committees and our amazing musicians, we were able to move from worshipping in church to worshipping online in a few short weeks. The gathering time before and after as well as conversation in worship has helped to keep us connected and gives opportunities to deepen our faith. I am grateful to Lisa Leffler, the Foodgrains Committee and Worship and Christian Education Committee for leading worship when I was off.

Pastoral Care — It was a gift to speak with so many of you when I set up the Circles of Care and I look forward to touching base again soon. I have appreciated the many phone calls I have received since the beginning of the pandemic. Hosting Coffee Connections and Tea and Talk most weeks on Zoom and meeting with the women outside at Ollie Darcie's for social distanced visits in the fall have been opportunities for me to connect. Helping with the Advent candleholders, sending cards, emails and Christmas cards continues to keep you in my heart.

Children and Young People – Gathering online gave me the opportunity to meet with our children at Rockwood and young people at Stone this fall. One Saturday morning a month, we have had Kids Time where we have explored the stories of Moses and the Christmas story with crafts, activities and videos. Conversations with the young people from Stone one Sunday evening a month have been about sharing how we are and where God is active in our lives. Megan Thomson and Amanda, Heidi and Emma Smits imagined the special music and retelling of the Christmas story out of our time together.

Christian Education – Our Bible Study group has been studying the Epistles and moved online early in the pandemic. In our conversations, we wrestle with Paul's writings that have shaped the Christian church for 2,000 years and how they impact our lives and faith. In the fall we moved to Tuesday evenings so that I could take Monday as a day off. I appreciate being able to participate in the Genesis Book Club; Spiritual Saturdays organized by Lisa Leffler and Heather DeJonge; and sharing in the planning of this year's Lenten Study with Karen Richardson and Lisa Leffler.

Outreach – It has been an exciting year to work with Rockwood Outreach and the Stone Foodgrains Committee as they planned the many creative activities to support Mission and Service, Anishnabeg Outreach, Canadian Foodgrains Bank, East Wellington Community Services and the Rural Women's Support Program. I am glad to support them through sharing ideas, helping to publicize their activities and by sharing their stories in worship. I was very grateful to help with building Anishnabeg Outreach's teaching lodge and two row wampum with members of our congregations.

Discernment Circles – I have valued the prayerful work of the Governance Discernment Circle drafting terms of reference for our Board and Pastoral Charge committees and position descriptions for church leaders. These were adopted by the Board in June. In 2021, we will be taking policies to our Councils for their approval. I have offered some support to the Affirming Discernment Circle and have been very grateful for their leadership in worship and the creative ways they have found to help us all reflect on how we can ensure our churches provide safe space for all people. The pandemic offered a time to continue making the Jeanne Jackson Reading Room a more inviting space. Thanks to all the volunteers who worked on moving the washroom door, dry walling, painting, cleaning and organizing the room. I am very excited to work with our Zoom Worship Circle. Not only are they helping improve our worship now, they are also exploring the technology we will need to have a blended worship when we return to our buildings.

I meet with our Board, Councils, Committees and Discernment Circles as I am able to offer support and co ordinate activities. I am especially grateful for the work of our Finance and Stewardship Committee encouraging stewardship, and the Reopening Commission for their prayerful decision making to keep our congregations safe this year. Working with Rockwood's Trustees this fall has been a gift as they imagine the future for our church property.

Administration – I am grateful to our board and councils for continuing to employ our staff through the pandemic. Our secretary Sharyn Southworth came into the office on Thursdays until the middle of March but has worked from home since then. In November, she spent a day at the church copying Christmas flyers. I pick up the mail each week. I am very grateful to our treasurers for their help with the annual statistics. I enjoy preparing the Annual Reports and newsletters and am grateful for Brian Mack's suggestions and everyone who helps with writing and editing. I prepared and sent the activity pages for the photo directory to IPC late in the spring. Carl Baker, Ellen Thomson and I approved the final draft in the summer, but the printing has been delayed because of COVID-19.

Continuing Education and Self Care – My continuing education included time reading and attending the Festival of Homiletics virtually. My ministry continues to be enriched by meeting with Guelph clergy for coffee once or twice a month. Meeting my support group and my spiritual director monthly helped to keep me grounded in this challenging year.

Cluster – It was a gift to worship with Erin and Ballinafad United Church when Rev. Felicia Urbanski and I exchanged pulpits in January. Barrie Hill members took part in the Pumpkin Growing Competition. The pandemic prevented new activities with our neighbouring churches.

Opening

Chairperson Steve Thomson called the meeting to order. The Annual Meeting took place in the Jeanne Jackson Reading Room and the Chair welcomed everyone in attendance. Rev. Heather Leffler opened the meeting with a prayer, following which she introduced everyone to the United Church's new on-line site called Church Hub on which are listed all United Church ministers and churches. Eventually, this Hub will include each church's living faith story. Heather invited attendees to give some thought during the meeting about how they would answer the question "If you had to tell someone one or two things about your church, what would it/they be?", for example, something exciting, memorable, a meaningful friendship and so on. More on this at the end of the meeting.

1. Voting Procedures

Moved by John Leffler that voting be made by a show of hands, unless voting by ballot is requested by one person. Seconded by Jack Ward. Carried.

Moved by Liz Guthrie that visitors be made corresponding members. Seconded by Brian Mack. Carried.

The United Church policy changed in 2018 to allow congregations to let adherents vote on all matters, not just temporal matters. *Moved by Carl Baker that adherents be eligible to vote on all matters at this meeting. Seconded by Eva Oliver. Carried.*

2. Minutes from the Annual Meeting for the year ended December 31, 2018

Moved by Edie Ward to accept the minutes as printed of the 94th Annual Meeting for the year ended December 31, 2018. Seconded by Murray Duffield. Carried.

3. Business from the Minutes

Heather thanked Brian Mack for his leadership of the Pastoral Charge Board, and during her sabbatical adding "It is wonderful to have his leadership".

4. Correspondence

Heather advised there was nothing to report.

- 5. Review of Annual Report for the Year Ended December 31, 2019
 - a) Pastoral Charge Reports (Report of the Board, Affirming Discernment Circle, Eramosa Ensemble, Faith/Food/Friendship/Fun, Finance and Stewardship, Ministry and Personnel, Minister's Report, Sabbatical 2019, Trustees and Trustees' Financial Report).
 - Affirming Discernment Circle: Liz Guthrie, participant in the Circle, shared that the twoyear process is ongoing and members of both Rockwood and Stone congregations will receive progress updates from time to time.

- ii) **Faith, Food, Friendship and Fun:** Brian Mack reported that under Lisa Leffler's capable leadership, his and other's craft skills are improving.
- iii) **Sabbatical 2019:** Bill Allen commended Lisa Leffler on her excellent leadership in worship during Heather's sabbatical.

Moved by Barb Parker to accept the Pastoral Charge Reports as printed. Seconded by Marg Baker. Carried.

b) Pastoral Charge Financial Reports (Financials for the Year Ended December 31, 2019 and 2020 Budget with Notes): David Smelsky (Rockwood) and Jack Ward (Stone) were thanked for their efforts in reviewing these reports.

Bill Allen explained that due to continuing growth in the Manse Fund, \$4,000 has been budgeted to be transferred from this fund to the Pastoral Charge 2020 Budget (\$3,000 was transferred in 2019).

Moved by Bill Allen to accept the Financial Reports as printed. Seconded by Peter Guthrie. Carried.

- c) Stone Reports: Tammy Smits moved that the Committee Reports be accepted as printed. Seconded by Liz Guthrie. Carried.
 - i) **Membership:** Heather asked everyone to take a moment to remember those who are no longer with us. We give thanks for every one of them for the ways they touched our lives and served our church Norm Craigie, Jean Martin, Bernice Milson, Joyce Hartung, Nancy Thomson, Bill Rowley and Ed Parker.
 - ii) **Bushels for Change Project:** Barb Parker clarified that she submitted information to Bill Allen, and Bill actually wrote the report.
 - iii) **Pastoral Care:** Karen Richardson is diligently documenting changes in membership. Going forward, Heather advised that as changes occur, they will be communicated via email allowing members of the congregation to update their copies.
 - iv) **Property and Finance:** Bill Allen congratulated Jack Ward on his management of the new windows project from leading the thought and planning process, obtaining quotes, hiring contractors to do the work, presenting the old windows for sale and finally, to successfully applying for and receiving a grant to offset the cost of the project from the United Church. Most importantly, Jack maintained regular communication with the congregation throughout. By the end of 2019, \$4,050 had been realized from the sale of the old windows and to date in 2020, another \$1,000 had been received, leaving a balance of around \$2,000. Congratulations to Jack who assured everyone that "all the old windows have gone to good homes."

Jack reported that, as part of the repurposing/updating the Jeanne Jackson Reading Room, as per the Discernment Circle for the project, the Property and Finance Committee is reviewing quotes to move the door to the washroom 180 degrees from its current location in order to create a more usable space in the room.

- v) **United Church Women (UCW.):** Sincere "thanks" was extended to the UCW, whose members quietly look after many events the church hosts during the year.
- d) **Stone Financial Reports:** Bill Allen, Treasurer, reviewed the Operating Statement from January 1 to December 31, 2019, and the Balance Sheet as of December 31, 2019. Key items were as follows:

- Weekly Givings at \$25,630 were down \$4,915.00 vs. 2018 at \$30,545
- PAR Givings were up \$4,352 at \$32,588 vs. \$28,236 in 2018
- Mission and Service donations (Weekly Givings, PAR Givings, UCW and Other) were slightly down by \$213.38 at \$11,715 vs. 2018, however, one late donation remains to be added.
- Foodgrains donations and fundraising have been very successful in the first year, netting at \$7,206.80
- Net Maple Syrup Sales were down slightly in 2019 at \$3,573 vs. \$3,770 in 2018
- the Chili Dinner saw net results down by \$263 in 2019 vs. 2018, partly because the Township did not waive the fee for the rental of Rockmosa Hall, as they had done in previous years. The explanation given by the Township was there had been a policy change. It was agreed that this matter required further follow-up with the Township.
- Interest earned from GICs in 2019 was \$976.50.
- the decrease in Church Operating Expenses for electricity and fuel oil can be attributed to the installation of the new furnace and, quite possibly, the new windows.
- Total Operating Expenses for 2019, at \$13,276.06, are down \$423.29 from 2018 at \$13,699.35. In sum, Bill reported that Stone Church is in "extremely good financial shape".

Eileen McDougall, who has so carefully maintained the Cemetery records and fund for many years, advised that we are not yet a 'closed cemetery' due to changes in burial laws allowing for more than one burial in a single plot. Eileen also advised that we receive donations from time to time for a burial. It was generally agreed that consideration should be given to levying a burial fee for cremated remains in future.

Barb Parker moved that the Stone Financial Reports as of December 31, 2019 be accepted as printed. Seconded by Ed Nagel. Carried.

e) **Stone Nominating Report for 2020:** It was noted that, inadvertently, Carl Baker's name was omitted from the Nominating Report for 2020 as the Broadview Representative. Carl continues in his role as an enthusiastic and diligent representative of this United Church of Canada publication.

Peter Guthrie moved the Nominating Report be accepted with this addition. Liz Guthrie seconded the motion. Carried.

Steve Thomson noted that all Committees have members, albeit Worship and Fellowship, Pastoral Care and Membership, Christian Education, and Property and Finance currently have some vacancies to fill for a full contingent. In addition, Susan Carothers withdrew her name as Recording Secretary, so the position of Secretary is vacant. To-date, no one has put their name forward for the position. Steve suggested that the time may have come for Council to review how many people are actually needed on various committees; that perhaps some committees could function with fewer members and those who wish to continue to serve might consider a move to another committee.

In the meantime, until the position of secretary is filled, members of Stone Committees and Council will fill the role on a rotating basis.

For the past year, a Governance Discernment Circle of the Pastoral Charge Board has been drafting position descriptions for various committee members and defining committee roles, as well as clarifying historical policies and procedures with the aim to updating these to maximize today's and future needs. The Governance Discernment Circle will convene one last time and meet with the Pastoral Charge Board to review the work undertaken, including designing a motto and writing a mission statement, for consideration of necessary/recommended changes to the Board structure.

All agreed that if someone has expressed an interest in participating on any committee, they should be encouraged to speak up.

6. New Business:

- a) Heather continued the conversation she began at the beginning of the meeting by handing out a form for each attendee to complete. The completed profiles will be compiled for inclusion on the Church Hub, and will be of assistance in any future search process for a minister. This will replace the "needs" process used in the past, as well as allow ministry candidates to search a church on-line and access the information and create a portal for anyone to learn about churches under The United Church of Canada umbrella.
- b) A query put forward by Peter Guthrie opened a conversation on Mission and Service (M&S). To clarify, the role of M&S historically was to pay missions as well as for all of the national Church's administration and staff, and a significant part of the Conference staff. Today, the national Church's assessment pays for all administration at the national level and for the Regional Councils. M&S is now used to pay for missions, including things like theological education, ministry support and vocation, and the staff that relate to the missions.

Bill Allen moved that Stone Church set its M&S budget for 2020 at \$12,000. Peter Guthrie seconded.

Bill Allen moved we have a \$20,000 target for all our outreach projects in 2020. Barb Parker seconded. Carried.

d) Joyce Duffield thanked Gwen Brander and Betty Storey for coordinating lunch following the meeting.

Peter Guthrie moved the meeting be adjourned. John Leffler seconded the motion. Carried.

Before everyone adjourned to the dining room for lunch, Rev. Leffler said grace.

Property

The annual Maple Syrup Fund raiser was very successful. Thanks to everyone involved in organizing, taking orders, picking up and making deliveries. Instead of our Annual Beef Dinner in October, Marg Baker, Liz Guthrie, Edie Ward and Barb Parker planned a series of take-out dinners. Dates were July (ham dinner), August (pulled pork), October (roast beef) and November (chili). Great response from everyone.

Water samples were done in January and again in July (just before first take-out dinner) and October.

Yard cleanup was attended by 17 people with social distancing.

The Church Reopening Commission developed instructions for safe entry to the church by individuals. The procedure has been adopted successfully at Stone. Sign-up sheets, hand sanitizers, gloves, wipes, cloths, and cleaning solutions are on the table inside the side door.

Volunteers took the opportunity with the church building closed to renovate the Jeanne Jackson Reading room. The door to the accessible washroom was moved and drywall installed to create an informal meeting area. The panelling on the remaining walls was painted as well.

Quotations were received to install insulation on the addition portion of the church. With Council approval by year end, work will commence in 2021. Thanks to Tom Parker and Don Martin for obtaining these quotes.

Finance

Although the Stone UC was closed most of the year to Sunday physical gatherings, members continued faithfully supporting the Church's ongoing operations and several outreach activities. However, we made good use of our left-over supplies, donating boxes of sausage and bacon to EWCS Foodbank as well as maple syrup for their Christmas hampers. In addition, all our pancake mix plus 2 gallons of maple syrup were gratefully received by the Guelph Drop-in Centre. As the Country Breakfast is a fundraiser for the general fund, we re-imagined it in the form of Breakfast for Dinner in which a hearty meal was auctioned by email on a monthly basis. This proved to be very successful and we extend a warm thank you to our generous bidders and cooks.

Outreach

As we reflect on this year of unprecedented events our thoughts are somewhat mixed. On the one hand, we on Outreach are truly thankful for our wonderful supportive and generous congregations. This year has been exceptional with so many responding in the most big-hearted way, enabling us to increase support to the folk we hope to help. On the other hand, the needs of many have increased significantly. Recently I read an essay suggesting that we are all free to choose whether to view this pandemic with optimism or pessimism. If only it were so simple. When we consider the plight of our Indigenous brothers and sisters with their tragic history, or the women and children living in abusive situations from which there is no respite during lockdown, or the local folks who, at the best of times struggle to put food on the table, we know this is absolutely not so.

This is how your support helped our neighbours both near and far.

Mission and Service (M&S): This year we are thankful that we received \$11,292 of our \$12,000 target for M&S. It was not unexpected that we would fall a little short given that we were unable to hold our planned Lenten fund raiser. Since beginning Zoom church services, we have enjoyed watching M&S

videos that keep us informed of the amazing difference gifts to M&S make both at home and around the world.

Rural Women's Support Program (RWSP): At Christmas time two Rockwood women receiving counselling through our local Rural Women's Support Program each received a \$75 Walmart gift card, and a child received a \$25 gift card to help them over the season. A donation of \$2000 will be made to Guelph-Wellington Women in Crisis, the parent organization of RWSP which has experienced a huge increase in demand for help during 2020.

East Wellington Community Services (EWCS) Foodbank: We are in touch with the foodbank on a regular basis and have responded to several specific requests this year. We have filled the freezer four times with nutritious foods, spending over \$1200 on this undertaking. At Thanksgiving, we purchased hams and at Christmas, we provided items for the food hampers, including bacon, sausages, muffins and maple syrup. During the Advent Magi March, everyone donated items from EWCS "much needed" list. As we continue to strongly support facilitating individual choice in food selection; prior to Christmas, we gave each adult a \$75 gift card for the grocery store of their choice plus a \$25 gift card for each child.

Anishnabeg Outreach: In February, we delivered a cheque for \$2500, and in the spring Rockwood and Stone decided to help AO with their Spirit Bundle Offerings with which they provided food, clothing and cleaning supplies to hundreds of urban Indigenous families. One component was gifting bicycles to each family member. Out of this the big Bicycle Bonanza was born. Thanks to social media and word of mouth the entire Rockwood-Eramosa community embraced the idea and 130 bicycles, trikes and other ride-on toys were dropped off at our collection location. Along with this we purchased 15 helmets, collected Canadian Tire money and donated \$500 Canadian Tire gift cards to fund more helmets. In addition, AO asked for masks for the Spirit Bundles, and immediately a cottage industry sprang up within our two congregations. About 6 or 7 skilled sewers produced and donated at least 400 masks. In August, some of us along with other members of Rockwood and Stone participated in laying a two row Wampum at the AO centre, laying two rows of pathway linking the Teaching Lodge and the Pollinator Garden. Recently we learned of a new AO Thrifting Program which requires funds to purchase sewing machines. These will enable AO to teach Indigenous women how to repurpose and upcycle clothing for themselves and their families and will also include a new prison day release program. The money raised from our Christmas arrangement sale plus Advent donations has provided the \$1000 needed for a machine, plus an additional \$100 for sewing supplies. Happily, an additional machine arrived having been donated by a friend of an Outreach committee member.

Special Requests: Outreach continues to ensure we can respond to the needs of drop-ins that ask for assistance by having a supply of grocery and gas cards available in the narthex.

The Guelph Drop-In Centre: They were the recipients of a large quantity of pulled pork which Sherol Steinberg had prepared for the cancelled RUC concert, and we added funds to purchase buns.

Outreach Fund-Raising Activities

Fortunately, a month before lockdown we held a wonderful **Robbie Burns Dinner**, albeit during a full-on winter storm. Outreach and friends made the dinner and decorations while the Eramosa Ensemble delighted everyone with an outstanding musical program. We had a piper and a splendid Scot who addressed the haggis with appropriate pomp and ceremony. Half of our profits of over \$1300 were donated to the general fund. Following that, our fund-raising happened while masked, sanitized and physically distanced. Keeping everybody safe being of paramount concern. The **Food Fix** started in May and ended in September with home-made meals being auctioned weekly via email. Next came **Feeding Our Flock.** Using chicken donated by Maple Lodge Farms we made and sold many meals, as well as

home-made gift-boxed preserves and shortbread cookies. The combined total from these two fundraisers was over \$4200.

In July, we organized a **Garden Tour** with help from the six generous families from Rockwood and Stone that opened their gardens with little notice, and also from Heather who produced a professional brochure. Even a weather event on the Sunday did not deter us! It was a tranquil and safe event with folk enjoying being together-apart. The total raised was \$635 shared between our churches. Have the seeds for a new summer tradition been planted?

The end of November found us making and selling outdoor Christmas arrangements with beautiful fresh greens, kindly donated and delivered by Cees Braamse, raising \$420.

After distribution of our raised money, we have a balance of \$1000 which we plan to hold over into 2021 to ensure we have sufficient funds on hand to respond quickly to any emergency needs. For a detailed financial record of how all the Outreach funds were distributed please see the year-end Operating Fund included in the 2020 RUC Financial Report.

Our hard-working committee members have been fearless in responding to the challenges of a year of global pandemic with enthusiasm and energy. We are grateful to the "friends of Outreach" that help us out in so many ways. Once again, we are so grateful to all the members of both RUC and Stone congregations who helped make it all happen. We thank you again, Heather, for your unfailing support and wisdom, and for your computer wizardry. Very many thanks also to Sharyn and Amanda for being who you are and for doing what you do with patience and humour.

We continue to be united in a common cause to walk humbly with God as we demonstrate love and support for each other.

The committee is going through the house, and when it is time, will have recommendations on items for salvage or sale. Thanks to those who have been helping sort and pitch things that have accumulated in the basement and the garage. When the Trustees have confirmed the paperwork is in order, we will move to disconnect the water and gas.

Church

Goetz Construction used the church parking lot during construction on Harris Street – in return they paved the minister's parking spot, the house driveway, and regraded, added gravel and recycled asphalt to the parking lot.

The large bathroom has been painted and the outside narthex stonework has been repaired. The water heater in the kitchen has been repaired and a myriad of small projects completed.

Projects coming up include replacing the fans in the sanctuary, renovating the narthex and improving accessibility. These projects are on hold until there is a firm timeline on selling the parking lot.

A huge thank you to Kevin Anthony for organizing volunteers to do snow removal for 2020-21. We are not clearing the entire parking lot as there has been limited use of the facility this year, so parking is not required.

We are working with the Reopening Commission to keep Rockwood United a safe place.

We have people going into the church and the house twice a week for insurance purposes while there are no in person activities.

We organized outside Christmas decorations at the church and were very pleased with the results and received lots of positive feedback. We will be storing the stable for use again next year. Thank you to all who came by and helped-it was truly special.

Finance

Thank you for your continuing generosity of money, time and talent- all contributions are necessary for the work of the church to continue. We are pleased to announce that we are now able to accept monetary donations by cash, cheque, credit card (through Canada Helps) and e-transfer.

In March 2020, how we did rentals changed due to the COVID-19 pandemic. To do this a Reopening Commission was struck, and Property and Finance Chairperson Sherol Steinberg was asked to be the contact person during the pandemic. This was to ensure that all pandemic protocols were adhered to.

Rentals to Rockwood were suspended in March. In the summer AA met distancing in the parking lot and in the fall moved to the sanctuary as it would accommodate more people, and this continued through the fall. Girl Guides also submitted a plan and were granted permission to use the facility when their governing body allowed them to meet. Early ON suspended their program in the spring and did not resume. There is currently no approval for use of the facility, and we continue to monitor the COVID-19 response as it pertains to our church.

Trustees held socially distanced meetings July 17 and August 6 in the church parking lot and August 26 in Day Hall because of weather. They met on October 14 and 28, November 11 and 25, December 9 and 23 via Zoom. Christine Wenger agreed to be the corresponding secretary for the committee beginning October 14. Heather Leffler takes the minutes.

The main focus of the Trustees activities in 2020 related to our property. Decisions to buy, sell, take out mortgages, leases, make major renovations, demolition or construct a new building are the decisions of the Council based on the recommendations of the Trustees. These decisions need to be approved by Western Ontario Waterways (WOW) Regional Council Covenant Commission. Sherol Steinberg as Chair of Rockwood Council was invited to join the Trustees meetings for these discussions.

East Wellington Community Services (EWCS) had been leasing the House since November 15, 2015. With their lease coming due in November, they gave notice on June 11, 2020 to end their lease on September 1, 2020. Improvements EWCS made to the House, including the air conditioner, and generator, remained with the building. It is planned to retain the generator for church use. The other assets can be disposed of once the final timelines are fixed.

Options Explored

Leasing the House: Initially Trustees considered leasing the house for one year. After consulting with realtors, the cost of renovating the house and rezoning the property to residential seemed prohibitive.

Selling 107 Harris St.: In 2008 when the Sunday School was growing, purchasing the House was a good investment for the future of the church. Waterloo Presbytery Extension Council purchased the property for RUC to allow time for us to get our deed in order. In 2015, Extension Council granted us \$50,000 towards the initial purchase as well as all the lease payments up until the purchase was finalized. They continued to hold the mortgage. Selling the House would involve a zoning change and severance costs. While we would realize a healthy profit, we would not honour the vision of purchasing the property.

Selling the Parking Lot: The parking lot was purchased in the 1970s and has served us well. Traffic continues to grow heavier and faster on Harris St. The lot is used by heavy trucks to turn around which increases the wear and tear on the surface. Selling the parking lot and developing a new lot beside the church would make parking safer and the church more accessible. It would also leave more options for development of our property in the future. There would still be funds remaining to help us continue to serve. The parking lot will not be sold until we have permission to demolish the house.

The congregation was kept informed through regular written updates in the weekly bulletin, a letter and newsletter, and verbally via Zoom in the weekly service. Following a physically distanced outdoor meeting on September 20 at the home of Ray and Ellen Thomson, the congregation had the opportunity to ask questions. The Council met that afternoon and on the recommendation of the Trustees agreed that the Trustees would seek WOW Covenant Commission approval to sell our current parking lot, demolish the House at 107 Harris Street, develop the property into a new parking lot, pay the mortgage on the property and use some of the funds to make the church accessible.

In October, the Trustees made the decision to try to sell the property privately for 30 days for \$720,000 and then use the Home Group as our realtor. Darryl confirmed, after approaching several local developers, that there is strong interest in purchasing the parking lot as a private sale from the church.

Western Ontario Waterways (WOW) Regional Council Covenant Commission: The Covenant Commission approved the listing of the parking lot for sale. The final sale is conditional on their approval. The Commission will also need to approve the use of proceeds from the sale. This will include paying the mortgage, demolition of the house, building the parking lot and accessibility in the church. We will need to name other ways the funds will be used.

Mortgage with Waterloo Presbytery Extension Council: The beginning balance for 2020 was \$151,505.82. Payments were \$550 per month and the mortgage was due for renewal in November 2020. Without lease payments, we were struggling to make payments. Extension Council approved the Trustees' request for a one-year mortgage at 2.7% with the condition that the mortgage is to be paid off in full on the sale of the parking lot before the house is demolished. The closing balance of the mortgage for 2020 was \$149,536.14 (which will be reduced by the contributions to principal from members of the congregation through 2020).

Investment with Frontier Capital Funds #20670253 was initially valued at \$17,956.41 on January 1, 2020. December 31, 2020, our investment balance was \$19,358.08. In an email poll in December the Council approved the Trustees' recommendation that the Trustees be allowed to use funds from the investment if needed to pay any upfront costs with regards to the sale of the parking lot, demolition of the house and construction of the new parking lot.

Insurance: Our broker is Colley Insurance. The House of Joy Policy No: 18879C02.3.0 is with Halwell Mutual. The church insurance is with Hub International Master Policy HUB1925 – 0836. There has been a 30% insurance increase in our insurance this year, reflecting unprofitable results in the industry and insurers stepping back from insuring old building.

The Trustees will continue to meet in 2021 to sustain this exciting development for our church. We thank the past Trustees who had the foresight to purchase the land for the car park and the congregation for supporting this and the purchase of the House of Joy that has allowed for these investments that in turn have provided this opportunity.
